## 2. The type of personal information we collect

We collect and process the following information:

- Personal identifiers, contacts and characteristics (for example, name and contact details)
- Website enquiry form (full name, email, company name, telephone number).
- How we get the personal information and why we have it.

## 3. Most of the personal information we process is provided to us directly by you for one of the following reasons:

- To process your job application.
- To send you details of future job roles you might be interested in.
- To send you information and updates on Digital & Delivery to keep you informed about the company (from a client/candidate perspective).
- To invite you to events that may interest you.
- To provide marketing information that may interest you.

## 4. Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing this information are:

- Your consent; You can remove your consent at any time. You can do this by contacting us at [info.admin@digitalanddelivery.com](mailto:info.admin@digitalanddelivery.com)
- When we have a contractual obligation
- When we have a legitimate interest.
- How we store your personal information
- Ensuring your information is securely stored.

## 5. We keep your personal information for no longer than two years. We will then dispose your information by deleting your data altogether from our databases and content management systems.

## 6. Your data protection rights

Under data protection law, you have rights including;

- *Your right of access:* You have the right to ask us for copies of your personal information.
- *Your right to rectification:* You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- *Your right to erasure:* You have the right to ask us to erase your personal information in certain circumstances.
- *Your right to restriction of processing:* You have the right to ask us to restrict the processing of your personal information in certain circumstances.
- *Your right to object to processing:* You have the right to object to the processing of your personal information in certain circumstances.
- *Your right to data portability:* You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.
- *You are not required to pay any charge for exercising your rights.* If you make a request, we have one month to respond to you.
